There is no current policy in relation to CCTV in hackney carriage or private hire vehicles. It is suggested in the guidance issued by the Department for
Transport that all licensing authorities should consult to identify if there are local circumstances which indicate that the installation of CCTV in
vehicles would have either a positive or adverse net effect on the safety of taxi and private hire vehicle users, including children or vulnerable adults
and taking into account potential privacy issues.
