4 APPLICATION FOR THE GRANT OF A PREMISES LICENCE: AARON'S CAMPSITE, AARON HILL FARM, CRAGG VALE, HEBDEN BRIDGE, HALIFAX HX7 5TX

The Assistant Director, Neighbourhoods submitted a written report seeking consideration of an application for the variation of a premises licence under the Licensing Act 2003, where relevant representations had been received.

Having given consideration to the report presented, and to representations made at the hearing from Environmental Health and the concerns of local residents relating to:

- Prevention of crime and disorder
- Public safety
- Prevention of public nuisance
- Protection of children from harm

and having considered the applicant's proposals for dealing with those concerns namely:-

- Noting the applicants offer to not allow children in the bar area after 9pm.
- The doors to be closed when amplified music is being played.

And having due regard to the provisions of the Licensing Act 2003, the statutory guidance issued under *Section 182* of the Act, the Council's Statement of Licensing Policy and the relevant provisions of the Human Rights Act.

RESOLVED that the application for the grant of the premises licence for Mr Ian King at Aaron's Campsite, Aaron Hill Farm, Cragg Vale, Hebden Bridge, Halifax HX7 5TX be approved subject to following amendments, exclusions and additional conditions to meet the licensing objectives:

- The doors to be closed after 10pm when amplified music is being played.

The Prevention of public nuisance:

Regard has been had to the representations of the applicant and those in support of the applicant, objections from the public, and from responsible authorities namely Environmental Health and Planning. Regard has been had to paragraph 2.19 of the Home Office guidance pursuant to section 182 of the Licensing Act 2003 which

states that appropriate conditions should normally focus on the most sensitive periods for people being disturbed by unreasonably loud music at night and into the early morning when residents in adjacent properties maybe attempting to go to sleep or are sleeping.
