- 5. Suicide Prevention** (Sue Forster, Consultant Public Health (Pages 3 - 80))
This item will consider suicide and suicide prevention in Calderdale, across all age ranges. Because of this, Children and Young People Scrutiny Board members have been invited to attend and participate in this discussion. The discussion will be led in "workshop style" by Sue Forster, Consultant in Public Health, with contributions from Calderdale CCG, South West Yorkshire Partnership NHS Trust and Council officers. The Scrutiny Board is asked to consider whether it wishes to make any recommendations to Cabinet, council officers or NHS bodies on suicide prevention.

6. **Transforming Community Services** (Rhona Radley , Deputy Head of Service Improvement and Director, Public Health (Pages 81 - 88))
Community services have been central to plans for the future in Calderdale, particularly since the development of the Care Closer to Home Programme in 2018. In July 2020, following the first wave of the COVID-19 pandemic, Calderdale Partners came together to take stock and review/reset the existing Care Closer to Home Programme, which is now known as 'Calderdale Collaborative Community Partnership Board' (3CPB). This item will consider the objectives of 3CPB and officers will describe examples of how it will be developed in practice.
7. **Covid-19 Update** (Verbal Report)
This month's Covid-19 update will focus on social care and residential care.
